Notional rent, rates and utility reimbursements for Bridge Street Surgery, Brigg, North Lincolnshire and Budget Update

1. CONTRACT ISSUES

1.1 Notional rent, rates and utility reimbursements for Bridge Street Surgery, Brigg

Bridge Street Surgery in Brigg currently operates under a General Medical Services Contract. Under this contract the practice are entitled to a reimbursement for their notional rent, rates and utility bills associated with the practice premises.

In accordance with "The National Health Service (General Medical Services-Premises Costs) Directions 2013" NHS England instructs the District Valuer to undertake a rent review every three years. Prior to this, the rooms and other space, including car parking spaces that is eligible for reimbursement is agreed between the practice and NHS England. Previously this fell under the remit of North Lincolnshire Primary Care Trust. During this time, the practice had leased some of their space to community nursing staff with rental income and this space was not reimbursed under the notional rent payment for this reason. In subsequent years, the community staff have vacated the property and the practice are utilising the space for a staff rest room, meeting room, kitchen, office accommodation and storage area. The practice has now requested that this is reconsidered by NHS England. The financial implications are as follows

Notional rent increase per annum - £6150 approx.

Rates increase - £1700 approx.

Utility bills - £100 approx.

Any increases to premises costs are funded through NHS England budgets and the amount suggested would need to be identified from the Primary Care budgets. Due to the fact that the space is now utilised for General Medical Services, it is recommended that the request is approved.

Recommendation: The Joint Commissioning Committee are asked to:

- consider the request from Bridge Street Surgery for the increase to their notional rent and associated costs.
- Approve the request

Report Title:	PMS Uplift

Introduction

Each year the Doctors and Dentists Review Body (DDRB) advises Government on rates of pay for Doctors and Dentists. For GMS contract holders once accepted the changes to pay rates are applied automatically.

For Doctors who hold locally negotiated PMS contracts the commissioner makes the decision if to apply the recommendations to local contracts. It is usual to accept the recommendations.

2015/16 DDRB Recommendation

The DDRB recommended an increase of £2.21 for GMS practices this is made up of \pounds 1.25 for inflation and \pounds 0.41 for the reinvestment of de-commissioned enhanced services (patient participation and Alcohol) and \pounds 0.55 for MPIG re-investment. Therefore they have recommended that PMS contracts are uplifted by £1.66 being the £1.25 inflationary uplift and the reinvestment of enhanced services of £0.41 the MPIG element does not apply to PMS contracts.

Financial Implications

The PMS review process set the baseline payment of £79.15 per weighted patient for the year commencing 1st April 2015. The inclusion of the DDRB uplift takes this to a value of £80.81.

The table below shows the additional resources required to implement the uplift this is funded through growth allocations that NHS England received.

Recommendation

The North Lincolnshire Joint Commissioning Committee is asked to approve the uplift to PMS contracts in accordance with the recommendations of the DDRB.
