Farewell and Hello

As you will be aware, our long standing Chair Dr Margaret Sanderson retired from the CCG at the end of May 2018. Her successor is Dr Faisal Baig. Faisal grew up and was educated in North Lincolnshire. I would like to welcome him to the role and I'm sure he will continue to ensure that local people benefit from the improvements that the CCG are making in the way health and care is commissioned in North Lincolnshire.

To strengthen the leadership of the CCG, the CCG is making a number of new appointments.

We have appointed a Head of People in conjunction with Hull CCG. Gill Mackin will be based at the CCG to offer local HR support to our team on Tuesdays and Thursdays. Gill has an extensive HR and OD background and will be a huge support to the organisation moving forward.

The CCG is in the process of recruiting a new Director of Nursing & Quality Assurance and I hope to be able to announce the successful candidate soon. We are also going out to advert for a Chief Operating Officer who will take on the role of Director of Commissioning as well as providing an enhanced level of leadership within

the CCG. Our former Turnaround Director, Julie Warren is currently covering the role on an interim basis.

Directions Update

NHS England have introduced a "Sunset Clause" in respect of legal directions which means that after a year of being in Directions, the CCG should automatically come out unless NHS England were to request otherwise. Whilst there are still some local issues to resolve, feedback about our delivery from NHS England has been positive so we are hopeful this will occur.

It was great that NHS England recognised the huge amount of work that had been undertaken by the team in improving the leadership and governance and stabilising the financial position of the CCG. Whilst there is still a great deal to do, it feels like we are heading in the right direction.

The review will be feeding into our final CCG assessment as part of the Internal Assurance Framework for 2017/2018.

NHS England Medical Director to Visit North Lincolnshire

Professor Stephen Powis, NHS Medical Director was in our area on Friday June 8th visiting Hull CCG, Hull & East Yorkshire Hospital Trust and then visiting Scunthorpe General Hospital to discuss the Humber Acute Services Review. We really welcome the national spotlight falling on North Lincolnshire as these are opportunities to highlight some of the exemplary work that goes on in our region, in spite of some of the challenges that we face.

Getting our medical systems talking to each other

As you may be aware the Humber Care Community is currently piloting the Interoperability between its two main Primary Care and Community Clinical Systems EMIS and SystemOne.

Early testing has proved this to be very successful, and we are looking to roll the integration out in the immediate future.

The inability to connect both systems has resulted in practical and clinical challenges and by connecting these systems, the ability for clinical professionals to access the information they need will be significantly enhanced.

NHS 70 celebrations

As the NHS turns 70 years old on 5 July 2018, I am extremely proud that anybody who needs its help or care can receive it - free at point of need - regardless of their background or means. We know the NHS has no boundaries in that respect and NHS staff, in every discipline, do a fantastic job year in, year out.
