Welcome to my update for June - July 2018, with news and highlights from around North Lincolnshire CCG.

North Lincolnshire CCG receives its 'Requires Improvement' rating

I want to begin with the very good news we have been rated 'requires improvement' under NHS England's (NHSE) annual assessment scores. This is an improvement from last year when we were judged inadequate. We have also been advised by NHSE that we will exit formal legal directions on the 14th August 2018. We will however remain in special measures until the 31 March 2019 due to our financial position.

I am, of course, delighted as it shows that we are on the right track with our approach, and we are strengthening our partnerships including our closer working relationship with North Lincolnshire Council. I know we still have a great deal to do but it is great that things are moving in the right direction.

I am immensely proud of the whole team for the work they do. The energy and commitment from everybody is immense - including all of our GPs, Governing Body, health and other partners. This is great news for North Lincolnshire and the people we serve and I have been pleased to receive a number of supportive messages since the announcement.

NHS Funding settlement 2018-23

The recently announced NHS funding settlement of an average 3.4% growth over the next five years is very positive. New growth funding will give us opportunities to invest over the longer term in areas where we are not doing as well as we should, and we will ensure we continue to drive value for every pound we spend.

I am always aware, however, that public health and social care continue to experience the impact of austerity and we must continue to work together to support vital public services for people in North Lincolnshire.

Place based board update

I attended the first North Lincolnshire Place Board on the 23rd of July. This is being led by the Local Authority but includes all the senior public sector leaders, including the Chief Constable, the Chief Fire officer etc. The aim of the board is for all public services to work together on a common agenda for the population to ensure we commission the most seamless services possible. I am looking forward to seeing how this develops over the coming months.

The art of a good AGM

The Angel was the venue for our fifth CCG Annual General Meeting. It was great to see such a huge turnout from general practice and members of the local community. I think we had a good story to tell about our year of two halves.

We ended with a very lively Question Time session. Thank you to everyone who attended and put us in the hot seat with your questions.

New Secretary of State for Health and Social Care

The recent reshuffle of a few cabinet ministers has seen the Rt. Hon Matt Hancock MP appointed Secretary of State for Health and Social Care.

His recent background is as Secretary of State for Digital, Culture, Media and Sport where he championed the digital transformation of government.

Mr Hancock, in an interview for the HSJ, said that the NHS, and the principle of a healthcare system that is free at the point of delivery, is one of our country's greatest achievements. He also promised to listen and learn and champion all the hard-working staff who make our NHS what it is today.

NHS North Future Talent Board

I've been very pleased to be asked to participate in one of NHS England and NHS Improvement's new Talent Boards. As a group of CCG Chief Officers and Trust Chief Executives we are starting to look at how we develop the next cohort of clinical and managerial leaders in the NHS and also local authority leaders as we move to more integrated systems. It will be interesting to see how this project progresses.

NHS 70 celebrations

We marked the 70th birthday of the NHS on 5 July 2018 in North Lincolnshire with a

number of special events, including a staff tea party to celebrate the achievements of the NHS.

I finished the day with the moving NHS commemoration service at York Minster, and it was great to hear how the NHS had touched the lives of so many people.

It was a wonderful day to celebrate the best of the NHS with 70 years as the nation's favourite public service, whilst looking forward to many more years.
